The expenses of travel, board and lodging will be up to each attending team.

## ENTRY FEES

Each participating country will pay the following entry fees:

- 400 US \$ for each country participating at the Senior Championships
- 100 US \$ for each senior skater entered for the Track Championship
- 100 US \$ for each senior skater entered for the Road Championship
- 50 US \$ for each junior skater entered for the Road Championship
- 50 US \$ for each junior skater entered for the Track Championship

It is allowed the participation only to countries affiliated to FIRS and updated with their FIRS fees.

#### **PARTICIPATION AT THE SENIOR WORLD CHAMPIONSHIPS**

A total of **eight** male and **eight** female skaters may be registered in the Championships for each attending country. No more than **two** male and **two** female skaters can participate in calendar events.

#### **PARTICIPATION AT THE JUNIOR WORLD CHAMPIONSHIPS**

A total of **eight** male and **eight** female skaters may be registered in the Championships for each attending country. No more than **two** male and **two** female skaters can participate in calendar events.

#### **DISTANCES**

**The race program will be the same for men and women, junior and senior categories**

##### **TRACK**

300 mt time-trial race  
500 mt sprint tournament  
1.000 mt sprint tournament  
10.000 mt points + elimination race  
15.000 mt elimination race  
3.000 mt relays (3 skaters only)

##### **ROAD**

200 mt time-trial race  
500 mt sprint tournaments  
10.000 mt points race  
20.000 mt elimination race  
5.000 mt relays ( 3 skaters only)  
The marathon is not in the program of this year

Please, take note that to attend the World Junior Championship a skater shall be aged 15 at the December 31, 2011. Skaters allowed to participate by their age shall although enter either the Senior or the Junior Championship only.

A skater having participated at a World Senior Championship shall not participate to any other World Junior Championship.

#### **ANTI DOPING CONTROL**

The anti doping control will be carried out according to FIRS Medical Regulations and WADA Rules.

#### **CONTROL OF FEMALE SEX**

No female sex certificate is required. Nevertheless, in conformity with IOC guidelines, FIRS is entitled to conduct some tests on specific occasions. This would mean laboratory tests could be done if there is a suspicion.

#### **RULES**

The CIC Official Regulations, 2011 edition with the latest amendments, and FIRS Rules will be valid for these Championships.

#### **PASSPORT CONTROL AND PAYMENT OF ENTRY FEES**

It is scheduled on August 29, 2011 at 09h00am at venue to be confirmed. Delegates of all attending countries are kindly requested to be present in order to confirm their entry and nationality, and for the payment too, if not made, of their entry fees. In case of payment made in advance, delegates must submit corresponding photocopy.

## PREPARATORY MEETING FOR THE WORLD CHAMPIONSHIPS

It is scheduled on August 29, 2011 at 03h00pm.

During the preparatory meeting Federations **must confirm skaters participating at each race.**
